2789 COUNCIL MANAGEMENT MATTERS

a. Village Christmas Tree

The meeting was advised that the contractor had been out to inspect the Christmas Tree and advised that the tree is not in a healthy condition. Members discussed the purchase of a replacement 10ft tree which could be planted into the ground and removed at the end of each season.

RESOLVED:-

To obtain a quotation from the contractor to deliver, plant and remove, at the end of the season, a 10ft Christmas Tree.

Standing Orders were suspended at this point in order to receive representation from Gwent Police.

POLICE REPORT

Two members of Gwent Police attended the meeting. The main issues within the local area were shed and garage break-ins with residents being asked to be extra vigilant in ensuring that they are secured. The PCSO advised that all residents can log into "Gwent Now" which is a free community messaging system for the Gwent area that allows you to register to receive the latest crime notifications and community news happening in your local neighbourhood available at www.gwentnow.org. "Your Voice" is another way in which residents can get involved with the setting of local ward priorities which for the Langstone ward and surrounding area are currently:-

Criminal Offence - Criminal Damage and Car Crime

Parking Problems - Illegal Parking

2790 PLAYING FIELD MATTERS

a. Weekly Inspection Report

Members received the weekly inspection report and noted that part of the hedge boundary in Glebelands sports field had been cut and the debris had been put in the field. In the case of overhanging trees in residents gardens, occupants are entitled to cut and place the cut branches back in the football field. Members were also advised that there were a few deeper than normal cuts on a couple of trees near the lane. Members agreed that during the weekly

inspections a closer record would now be kept of the condition of the trees and boundary hedge.

With regards to the grass cutting and hedge maintenance, the meeting was advised that the Clerk had been in contact with the contractor who has apologised for the service received this season and that there seemed to be a breakdown in communication at their end. The contractor advised that the hedges would be cut, by hand, on Thursday, 19th October 2016.

b. Annual Inspection

Members considered the action plan following the annual inspection of the play equipment.

RESOLVED:-

To carry out the following actions:-

- Remove the bay timber toddler swing due to decay in the uprights and obtain quotations for replacement a member has safety taped off the swing in readiness for removal.
- Strengthen the legs on the benches a member has agreed to carry out the leg strengthening.
- To investigate an appropriate Play Area sign clerk to action
- To obtain a quotation to have the zip wire re-tensioned, adjustment of the cable stop and adjustment of the starting section buffer awaiting quotation from contractor.
- To clean the algae growth on the springer elephant a member has agreed to clean off the algae growth.
- To repair the splinter hazard at the end of the log climber awaiting response from contractor.
- Removal of excess links at the top of the traditional swing and removal of algae growth on the safety surface a member has agreed to remove the excess links and awaiting quotation from contractor regarding algae removal
- Replace shackle on tradition swing awaiting quotation from contractor
