The council is working on the production of a Replacement Local Development Plan (RLDP) for Newport. The RLDP will set out a 15 year land use framework for the city.

■ What's happening now?

Consultation: 25 October 2023 – 20 December 2023

The RLDP will guide the development of the city over the next 15 years, and this is your opportunity to get involved.

Interested parties are invited to make comments on these technical documents as a part of the Preferred Strategy consultation.

Preferred Strategy (Pre-Deposit Plan)

The Preferred Strategy identifies the key issues which the plan seeks to address; the Vision for the plan and supporting objectives; the proposed growth strategy for housing and employment land; the spatial approach to delivering new development; Key Sites which are proposed to be taken forward; strategic planning policies to support the delivery of the plan strategy.

Accompanying the Preferred Strategy is a suite of supporting technical reports and evidence that were used in its preparation.



Integrated Sustainability Appraisal Report and Habitats Regulations Assessment

An Integrated Sustainability Appraisal (ISA) and a Habitats Regulations Assessment (HRA) are required as part of the development of the RLDP.

The ISA appraises the potential for positive and negative effects against a sustainability framework. The HRA is an assessment of potential effects of protected European sites.

An Initial ISA Report and HRA Screening Report have been made available for comments and can be viewed alongside the Preferred Strategy.





Candidate Site Register

A 'Call for Candidate Sites' was undertaken in 2021.

Following this, the Council have prepared a Candidate Site Register which is a record of the sites submitted to the Council.

The Candidate Site Register does not propose site allocations but is simply a record of land submitted to the Council for consideration and provides the results of an initial filtering exercise.

Additional Candidate Site Submission

As part of the Preferred Strategy Consultation additional Candidate Site proposals are able to be submitted for consideration, as set out in the Development Plan Manual (March 2020).

Submissions should be made using the Candidate Sites Form, Guidance Note and Assessment Methodology.

Please note there is a new Developer Viability Model (DVM) available to accompany Candidate Site submissions.

It is important to note that the submission of a Candidate Site does not represent a commitment on the part of the Council to take sites forward into the RLDP.

In person drop-in sessions will be available for you to meet with members of the Planning Policy Team where you can discuss any questions you might have about the Preferred Strategy.


