The Council approved its Annual Governance Statement before receiving the Internal Audit report. When approving the Annual Governance Statement, the Council lacked the evidence to support its assertions. We recommend that for 2021-22 onwards, the Council receives and considers the Internal Audit report before it approves its Annual Governance Statement.
