Resolved:

Members reviewed the list of outstanding queries awaiting completion noting that the walk around the village to discuss outstanding issues with the Ward Councillors needs to be rearranged.

Resolved:

- i. To send the outstanding queries list to the Ward Councillors asking that items are chased where necessary and request that they suggest a few dates for a site visit.
- ii. To make progress on updating the Financial Regulations and Standing Orders.
- iii. To forward the measurements for the log climber to the manufacturer.
- iv. To contact Newport City Council to see if they can assist with the Bylaw signage.
- **b.** Democracy and Boundary Commission Wales Draft Annual Remuneration Report Members noted that the Draft Annual Remuneration Report 2026/27 has been published and is open for consultation until 18 November 2025. The Commission welcomes feedback from all stakeholders to inform the final determinations, which it intends to publish by the end of the year.

Resolved:

Members received the Written Statement: Update on actions to support the role, governance and accountability of the community and town council sector from the Cabinet Secretary for Housing and Local Government.

e. Newport City Council - Notification of Consultation: Community Boundaries and Electoral Arrangements Review

Members noted that Newport City Council is undertaking a comprehensive review of community boundaries and electoral arrangements across the principal council area, in line with the requirements of the Local Government (Democracy) (Wales) Act 2013 - closing date 23.11.25.

4088 Playing Field Matters

a. Fortnightly Inspection Report

i. Members received the fortnightly inspection report as follows:

Childrens Playing Field

- Old e-mail address on sign
- One of the trees appears to have died
- There are a lot of moles hills in the park at present.
- Grass has not been cut for a few weeks.
- Hedges have all been cut and appear satisfactory
- All play equipment appears safe and serviceable.
- Bench and picnic tables all appear OK.
- The wooden base to the plaque of the children names that planted the trees has rotted.

Resolved:

- i. Contact Newport City Council regarding the decayed tree.
- ii. Ask Newport City Council to undertake a grass cut when spraying the foot path in November as per the contract.

Playing field

- Hedges have been cut
- Grass has not been cut for a few weeks
- Very few mole hills
- Gate post rotten
- Damage to fence
- Incorrect e-mail on sign

ii. Members considered the quotation received to make good the trampled wire fence and replacement/making good to gate receiver post in the football field at a cost of £380.00.

Resolved:

To clarify with the contractor whether the quote includes replacement of 3-4 wooden posts supporting the wire fence.

iii. Members considered the report detailing sample signage and costs to advice of uneven ground in the playing field.

Resolved:

To purchase a sign at a cost of £10.89 plus VAT (LG 1976 (MP), s19).

iv. Members noted that Newport City Council have confirmed that there are 3 grass cuts outstanding and that they will finish the hedge work in the near future.
